Introduction

Originally opened in 1995, DEN currently serves over 25 different airlines and over 200+ destinations throughout the Americas, Europe, and Asia, and is the largest employer in Colorado, with over 35,000 employees and is the primary economic engine for the state of Colorado, generating more than \$36.4 billion for the region on an annual basis. It is also the third busiest airport in the world in 2022, with nearly 70 million passengers traveling through the airport.

Procurement Process

This will be a two-step procurement process, as outlined in the timeline listed below, with vendors responding to this Sources Sought with a Statement of Interest. All qualified vendors responding to the Statement of Interest will be issued the Request for Proposal,



and selection of the Vendor will be made based on a best-value evaluation criteria that will be issued with the RFP.

Intent of Sources Sought and Request for Proposal Procurement Process

This Sources Sought and Request for Proposal is intended to provide The DEN PACS¹ team with market interest and information that will be used to guide technology selection and procurement for the DEN PACS and will be part of a two-step procurement process as noted above. Procurement of the selected technology will utilize an existing DEN contract. This Sources Sought shall not limit any rights of the Airport. DEN reserves all

its rights including, but not limited to its right to elect not to procure the products or services that are the subject of this Sources Sought and to procure them from a vendor that has not responded to this Sources Sought. DEN shall not be obligated to respond to any submittal, nor shall it be legally bound in any manner whatsoever by the receipt of a submittal. DEN makes no representation that a contract is awarded to any Respondent to this Sources Sought or Request for Proposal. Objective

As part of DEN's continuous improvement program, DEN is planning to replace its Physical Access Control System (PACS) at DEN. The current system is originally from Cyber Country, with intelligent door controllers connected back to network switches.

Vendor Qualification Criteria:

- 1. The equipment manufacturer shall have been in business manufacturing similar products for at least ten (10) years.
- 2. Equipment shall be installed by qualified individuals having at least five (5) years' experience installing and maintaining similar equipment. The qualified individuals shall have at least three (3) systems of similar type and size within the past five (5) years.
- 3. Submit evidence of successful installation, Owner training and maintenance for a minimum of the previous five (5) years.
- 4. Must be a commercial off the shelf provider, no proprietary solutions will be accepted.
- 5. Demonstrated experience in successfully performing programs of at least fifty (50) million-dollar value

- Compliance with applicable flow-down requirements from the Prime Contract
